In-House Registration

All current students and church members are offered spaces before the public.

Current enrollment does not guarantee a space in a class for summer or for next year.

WILL BE CONSIDERED.

In-House Registration Procedures:

All completed registration forms will be dated when received, beginning February 10, 2020.

First Day of In-House Registration - All registration forms with the required Registration Fee that are submitted on February 10, 2020, will be separated into the desired classes. If there are more students applying for a certain class than spaces available, then a lottery will be held. The class list and waiting list, if necessary, will be determined on this first day. Please note: Parents will receive class placement notification on Tuesday, March 10, 2020.

Second Day of In-House Registration until Public Registration - All registration forms with the required Registration Fee that are submitted will be accepted on a First Come First Served basis.

Public (Open) Registration

Any spaces remaining after In-House Registration will be offered to the community beginning on Monday, February 17th. ONLY COMPLETED REGISTRATION FORMS ACCOMPANIED WITH THE REGISTRATION FEE WILL BE CONSIDERED.

Public (Open) Registration Procedures:

First Day of Open Registration - All registration forms with the required Registration Fee that are submitted on February 17, 2020 will be separated into the desired classes. If there are more students applying than spaces available in a certain class, then a lottery will be held at the end of that business day for the remaining spaces and for status on the waiting list, if necessary.

Second Day of Public Registration until classes filled - All registration forms with the required Registration Fee that are submitted will be accepted on a First Come First Served basis.
